## Chenango Forks Community Association Sports Programs <u>Coaches' Code of Conduct and Ethics</u>

The function of a coach is to educate students through participation in youth athletics. Each youth athlete should be treated with a high degree of respect and appreciation for their own abilities, and the safety and welfare of each youth athlete should be uppermost at all times. As a coach in a Chenango Forks Community Association sports program, I recognize that I have responsibilities to my players, my cocoaches, and my community. I therefore agree that I will:

- 1. Promote good sportsmanship by setting a positive, encouraging example while coaching youth athletes.
- 2. Treat players, other coaches, officials and spectators with respect regardless of race, creed, color, sex, or ability.
- 3. Respect the integrity and judgment of the sports officials.
- 4. Approach competition as a healthy and constructive exercise, which does not require victory as a standard by which success is measured.
- 5. Recognize that the participants are youth athletes, with many limitations and they will make mistakes.
- 6. Ensure that activities being undertaken are suitable for the age, experience, ability and fitness level of all athletes.
- 7. Not engage in crude, abusive, profane language with youth athletes, officials, or spectators.
- 8. Refrain from physical or verbal abuse of any athlete, official, coach, or spectator.
- 9. Instruct youth athletes in the elements of good sportsmanship, and remove players from competition who demonstrate unsportsmanlike behavior.
- 10. Avoid behavior that may incite youth athletes, opponents, or spectators.
- 11. Refrain from the use of illegal drugs, alcohol, and tobacco while coaching or interacting with athletes.
- 12. Be aware of the academic pressures placed on student athletes, and conduct practices and games in a manner so as to allow academic success.
- 13. At no time become intimately and/or sexually involved with any youth athlete. This includes requests for sexual favors or threat of reprisal for the rejection of such requests.

I also agree that if I fail to abide by the aforementioned rules and guidelines, I will be subject to disciplinary action that could include, but is not limited to the following:

- Verbal warning by official, and/or head of league organization
- Written warning
- One game suspension with written documentation of incident kept on file
- Removal from coaching responsibilities, and banishment from any future coaching privileges in CFCA activities.
